F. **DECLARATION AND OATH BY THE PERSON NOMINATED REGARDING ASSETS AND LIABILITIES.**

I hereby solemnly declare to the best of my knowledge and belief that;—

- i) No loan for an amount of fifty thousand rupees or more obtained from any bank, financial institution, cooperative society or corporate body in my own name or in the name of my spouse or any of my dependents, or any business concern mainly owned by me or the aforesaid, stands unpaid for more than one year from the due date, or has got such loan written off; and

 - ii) “mainly owned” shall mean holding or controlling a majority interest in a business concern;
 - iii) “taxes” include all taxes levied by Federal Government, Provincial Government or a local government, but shall not include taxes the recovery of which has been stayed or suspended by any order of a court or tribunal;
 - iv) “government dues and utility charges” shall, inter alia, include rent, charges of rest houses or lodges owned by Federal Government, Provincial Government, local governments or corporations established or controlled by such governments, but shall not include the government dues and utility charges the recovery of which has been stayed or suspended by any order of a court or tribunal.
