NOTIFICATION

Islamabad, the 19th August, 2013

No.F.8(3)/2013-Cord.- In supersession of this Commission's Notification of even number dated 13th August, 2013 and in exercise of the powers under section 86A of the Representation of the People Act, 1976 (LXXXV of 1976), the Election Commission hereby authorizes, each designated officer-incharge of the Army, Rangers or FC of an area, deployed for providing security inside and outside polling stations of that area of the following constituencies, to exercise powers of Magistrate First Class on the polling day i.e. 22nd August, 2013, in respect of offences punishable under section 80, section 82A, section 83, section 84, section 85, section 86 and section 87 of the aforesaid Act and to take cognizance of any such offence under any of the clauses of sub-section (1) of section 190 of the Code of Criminal Procedure and to try any such offence in a summary way in accordance with the provisions of the said Code, relating to summary trials.

2. The Army troops (including Rangers, FC) deployed inside or outside a sensitive/highly sensitive polling stations, while performing their security duties are supposed first to report to the Presiding Officer any irregularity/malpractice they observe inside or outside the polling station and act according to the instructions issued by him in that regard. In case the presiding officer does not act to prevent the commission of any reported irregularity/malpractice, the security staff will immediately bring the matter to the notice of the designated officer incharge of the area of his respective constituency for action, in the light of the powers delegated to him under this Notification, as he deems appropriate.
